With reference to your application on the subject cited above. I am directed to convey the approval of Director of Education, Govt. of NCT of Delhi for grant of **Provisional Recognition of (NAVEEN PUBLIC SCHOOL-1412142) from Secondary to Sr. Secondary level with Arts and Commerce Stream w.e.f session 2020-21 upto 31/03/2022** subject to the following terms and conditions:-

1. That the school shall abide by the provision of DSE Act, 1973 and RTE, 2009 rules made there under as well as the instructions issued by the Director of Education from time to time.
2. That the school shall admit the students without any discrimination of religion race, caste or place of birth as per the norms of the Department.
3. That the school shall admit the students without any discrimination of religion race, caste or place of birth as per the norms of the Department.
4. That the school shall follow the three language formula for teaching.
5. That the school shall not run any unauthorized classes or any other activities within the school premises and all the recognized classes shall run at one place in the premises of school.
6. That the managing committee shall regulate the functioning of school strictly in accordance with the provisions of DSEAR 1973/RTE Act, 2009.
7. That the Management of the school shall create a reserve fund in the form of Fixed Deposit in the joint account in the name of Manager of the School and Dy. Director of Education (Distt.) equivalent to 3 months salary of staff or Rupees One lakh + Rs 80/- per student within 3 months from the date of issue of letter.
8. That in no case the school funds will be diverted/ transferred to any other fund/account of the society. The school funds will also not be utilized by the society for any other purpose other than that of the school.
9. That the school shall ensure that the Fire safety equipments and arrangements are maintained as given in circular No 262-362 dated 17/1/2005 and corrigendum dated 27/1/2005 issued by Directorate of Education.
10. That the school shall comply with the directions of Hon'ble Supreme Court regarding the arrangement made for transporting school students to and fro the school as per Circular No. DE 23(47)/School Br/2004/6942/ 66988 dated 29/9/2004 & 18/11/2005.
11. A certificate from the competent authority that the Building has been constructed as per National Building code 2005 with in three months.
12. Salary & other facilities to staff and teachers will be made as per section 10(1) of DSEAR 1973 and relevant section of RTE Act, 2009.
13. Salary to the staff should be made through crossed cheque/ Electronic clearance system.



- 14 That the school shall provide free and compulsory education to the children as per notification no 15(172)/ DE/Act/2010/69 dated 7/1/2011.
- 15 That the annual return under rule 180 of DSEAR'73 shall be filled with the concerned DDE Zone
- 16 That the school shall abide by the instructions/orders regarding fee-hike, issued by the Dte. of Education
- 17 That this shall be subject to submission of outcome of notification of MoUD, GOI.
- 18 That the violation of any instructions/order/rules and regulations of the department, shall lead to the withdrawal of recognition of the school
- 19 Appointment of requisite teaching staff and HOS as per requirement and RRs laid down by DoE
- 20 Complying with the provisions of DSEAR, 1973, RTE Act, 2009 and directions / instructions issued by the Department, time to time.
- 21 That the school shall comply with the provisions of Rules 176, 177, 18(5), 17 (3) & order dated 15.12.1999, 10.05.2005, 11.02.2009, 16.04.2010 & 19.02.2016 dealing with the regulation of fee along with the subsequent orders issued by DoE from time to time.
- 22 That the school shall comply with the order dated 07.11.2011/guidelines of DoE and judicial pronouncements w.r.t. safety & security of the school children and take all steps in this regard.
- 23 That the school shall appoint one more special educator within 60 days as per order dated 19.02.13.
- 24 Registered lease deed w.r.t. plot measuring 1008 sq yards shall be submitted within 60 days
25. Deficiencies pointed out above, must be rectified before the next physical inspection of the school as per order dated 17.11.2020


