RULES AND REGULATIONS OF MANAH SENG SOCIETY,
F2/32 HANU PURI DELHI-831

1. The membership of the society shall be open to all the residents of Delhi. Who pay Rs. 5/- admission fee and Rs. 50/- per monthly subscription subject the approval of the managing committee. The reason for rejection of membership shall be communication to applicant.
2. The managing committee shall have full power to expel any member from the date of due.
 - (a) If he has not paid his subscription for more than three months from the date of due.
 - (b) If he has not attended three meetings of the society without any intimation.
 - (c) On his written resignation or his death.
3. If the appeals should be sent to the general body of the society decision of general body will be final the reason for rejection shall be communicated to the person concerned.
4. Every member has been expelled by the managing committee, can be readmitted with the consent of Managing Committee.
5. The source of income of the society shall be grants donations special contributions, subscription and admission fees.
6. All income of the society shall be deposited in the bank.
7. The bank account of the society shall be operated by office bearers from general secy and treasurer.
8. The general body consist of all members of above category as described in membership classes.
9. The general body will meet at least once in a year.
10. The general body will consider any business brought forward by the managing committee including the annual and budget and part of the working of the society.
11. Not less than 15 days notice shall be given to the members before the date of general body meeting enclosing the agenda specifying date time and place.
12. The general body in its annual meeting will elect its President and office bearers ad number after every three years by raising of hands and quorum of the general body ad managing committee shall be one third.
13. The strength of the managing committee shall be not less than seven members and not more than eleven members excluding office bearers.

14. The terms of the managing committee shall be three years.
15. The managing committee will arrange finance if required from the other banks institution or individuals on reasonable terms and conditions.
16. The managing committee will be responsible for implementation of decision taken by the general body and will make plan for the future programme of the society.
17. The managing committee will meet atleast once in three month for which 10 days notice will be required.
18. This managing committee will appoint and terminate duties of any staff.
19. The president will be head of the society and president over the meeting or the general body and managing committee. He will have the right of casting vote in case of the problem.
20. All the correspondence of the society shall perform all such other duties which may be assigned by the managing committee from time to time.
21. In incidence of the secy. the jt. secy will be responsible for his functions/duties.
22. The treasurer will keep accounts of all receipt and expenditure of society and will furnish necessary information to managing committee. He will keep 500/- with him and the balance amount will have to be deposited in the banks.
23. To intime to the members about the meeting of the society the meeting of the society and to keep United the society. To work in co-operation with the secy.
24. Prop. secy. i- To implement the effective resources of propnids for society in co-operation with secy/president.
25. Managing secy. - To managing the arrangement of the society, Govt. meeting programmes, symposium, etc, to gather in co-operation with secy/president.
26. The accounts of the society shall be audited atleast once in year by an auditor appointed by the general body.
27. The financial year of the society shall be 1st April to 31 March every year.
28. Every year list of managing committee members shall be filed with the office of the registrar of societies as per section 4 of the S.R. Act.
